
FROM OUR PRESIDENT

TRUMP SECURES DECISIVE VICTORY, **REPUBLICANS TAKE SENATE AND HOUSE MAJORITIES**

Former President Donald Trump surpassed the electoral vote count needed to win the election and is now only the second president to be elected to two nonconsecutive terms. Trump secured 312 electoral votes to Harris' 226, flipping the critical battleground states of Pennsylvania, Michigan, Wisconsin, and Georgia and holding North Carolina. Trump is also the first Republican presidential candidate to win the national popular vote in 20 years, garnering just under 77 million votes to Harris' 75 million. In an statement issued post-election, ABC President and CEO Mike Bellaman congratulated former President Trump on his victory and added that "ABC is optimistic about the future of America's construction industry and the opportunities to advance policies that protect free enterprise, reduce regulatory burdens and expand workforce development."

Republicans also won a majority in the U.S. Senate where three ABC-supported candidates secured victories. West Virginia Governor Jim Justice will be the state's next senator after securing almost 70% of the vote. Businessman Bernie Moreno officially handed the GOP its majority when he unseated Sen. Sherrod Brown in Ohio while former Navy Seal Tim Sheehy expanded the Republican edge after taking down Sen. Jon Tester in Montana. Other GOP candidates are still in competitive races that are still too close to call, including Dave McCormick in Pennsylvania and Sam Brown in Nevada.

Republicans have currently gained one seat while a few GOP incumbents fell to their Democrat challengers. ABC "All In" candidates had success on election night, with Michigan Rep. John James winning reelection and Tom Barrett claiming the state's 7th district, while Rep. Susan Wild conceded to ABC-supported state Rep. Ryan Mackenzie in Pennsylvania's competitive 7th district.

The Free Enterprise Alliance launched several issue advocacy videos this year, all of which can be viewed on YouTube and ABC PAC. They also launched their largest independent expenditure campaign spend in history - running digital ads in key states Florida, Michigan, Montana, Ohio, Pennsylvania, and Texas.

ABC Legislative and Regulatory Priorities for the Trump Administration:

With President Donald Trump's second term beginning in January 2025, and Republicans taking control of both chambers of Congress, ABC is ready to advance our members' legislative, legal and regulatory priorities.

Some ABC priorities entering 2025 and the 119th Congress include:

• Labor and Employment: Strengthening the rights, flexibility and privacy protections of workers by reintroducing and passing legislation such as the Employee Rights Act.

• Tax and Fiscal Policy: Preserving provisions of the 2017 Tax Cuts and Jobs Act that support small businesses in the construction industry.

• Nominations: Advancing qualified nominees at the U.S. Department of Labor, National Labor Relations Board, Department of Transportation, Environmental Protection Agency, Education Department and other relevant agencies.

• Fair and Open Competition: Supporting fair and open competition in the construction industry through legislation and regulation, ensuring that all construction companies can compete for federal construction projects, regardless of labor affiliation.

• Workforce Development: Promoting an all-of-the-above strategy to workforce development.

• Immigration: Creating a market-based merit visa system specifically for the construction industry.

• Permitting Reform: Advocating for common sense permitting policies that streamline and modernize the federal permitting process.

 Regulatory Reform: Repealing and reforming regulations that prevent taxpayers from getting their best value on their investments, disrupt longstanding relationships in the construction industry, limit flexibility, and disproportionately impact small businesses.

- Q: I know the ABC members in northwest Wisconsin know a little about you, but can you tell all ABC of Wisconsin members a little about your background.
- A: I am a small businessman and political outsider with nearly three decades of experience starting, building, and operating businesses in northeast Wisconsin. My goal is to bring that experience to Washington to solve problems for the people of Wisconsin's 8th Congressional District. Alongside my wife, Angela,

I owned several Dino Stop gas station convenience stores, and Little Caesars restaurants. I know firsthand how burdensome government regulations can be on small businesses, and I'm committed to reducing the size and scope of government.

Q: Why did you decide to run for Congress?

A: Our country is at a crossroads. We face serious challenges both at home and abroad, rising prices, open borders, crime, and global instability. These issues demand strong leadership in Congress. As I traveled across all 11 counties of Wisconsin's 8th Congressional District, I asked voters, "Are you better off than you were four years ago?" The answer was a resounding "no." I ran for Congress because I can no longer stand by while politicians prioritize their own interests and those of foreign nations over that of the American people. Over the past four years, the Biden Administration's policies have led to record inflation, a border crisis, and growing conflicts abroad.

Q: What did you hear from the voters during the campaign?

A: Throughout my campaign, I met with several ABC members who all shared the same frustration with high taxes and overbearing regulations. I'm committed to working with the House GOP and President Trump to cut red tape and allow Wisconsin businesses to thrive. With Trump's tax cuts set to expire, another priority is extending these cuts. I believe strongly that the American people work hard for their money, and it belongs to them, not the government. I will ensure we put more money back in your pockets.

Another top issue I heard from constituents during my campaign was the need to secure our border. The Biden Administration's policies have led to unprecedented levels of illegal immigration. This is nothing short of an invasion. Every state is now a border state. I've spoken with sheriffs in my district who are dealing with criminals in their jails who aren't U.S. citizens.

We must reinstate the "Remain in Mexico" policy, continue building the bor-

der wall, and fully fund our border agents, giving them the resources they need to protect our country.

- Q: In addition to continuing the Trump tax cuts and securing the borders, what are your top three priorities during your first term?
- A: One of my top priorities is restoring our economy. Inflation is a tax, and it hits the poor and middle class the hardest. Over the past few years, we've seen rising prices at the grocery store and gas pumps, stretching household budgets. The root cause of

inflation is reckless government spending. Under the Biden Administration, government spending has reached unprecedented levels. Our country is already \$36 trillion in debt, and we're now paying more interest on that debt than on the debt itself. Yet, the Biden Administration's solution was more spending. The so-called "Inflation Reduction Act" only increased costs for everyday goods. During President Trump's first term, we saw lower prices and interest rates, and I believe he can achieve that again.

Second, We must also become not just energy independent, but energy dominant. The Biden Administration canceled new drilling leases and shut down pipelines while allowing foreign nations like Russia to develop their own energy infrastructure. The House GOP will work with President Trump to cut the red tape and unleash American energy, driving our economy and reducing our dependence on foreign adversaries.

Finally, with President Trump back in the White House, we can restore peace and security around the world. Under President Biden, we've seen conflicts in Eastern Europe and the Middle East, a disastrous withdrawal from Afghanistan, and currently have drones flying over U.S. airspace that the administration seems either disinterested in or incapable of addressing.

Under President Trump, we will end endless wars abroad and lead the world with peace through strength. President Trump was the first president in recent history to prevent any new wars. When he returns to office, the world will know that the U.S. means business. The House GOP has already shown its commitment to strengthening our military by passing the National Defense Authorization Act for FY25, with my support.

Q: So, you get the feeling that the Republican controlled House of Representatives will be able to get work done even with its narrow majority?

The House GOP will work with President Trump to ensure these policies are permanent, preventing future administrations from undoing our progress and bringing us back to the chaos we're seeing today. There's much work ahead, but I'm ready to join President Trump and the House GOP in solving these problems and getting our country back on the right track. In the 119th Congress, the Republican Party is united and ready to work with President Trump from day one to get our country back on track. *Research*



SUPREME COURT, APRIL 2025

I just finished up five rewarding years on the ABC of Wisconsin board of directors, including a one-year term as Chair. While I will miss serving you in that role, I am excited about joining the ABC of WI legislative committee, and my first priority is to work with the Chapter and its members on helping elect a true conservative to the Wisconsin Supreme Court – former Wisconsin Attorney General Brad Schimel. Yes, it would be nice to rest on the political successes that we achieved last November – election of President Trump, Republicans taking control of the US Senate, and several key ABC champions being elected or re-elected, including Wisconsin's newest Congressman Tony Wied (ed note – see page 14 for a scorecard of how ABC of WI champions fared in November).

I THINK THE APRIL 2025 ELECTION WILL BE DIFFERENT BECAUSE CANDIDATE QUALITY MATTERS.

But, it's important to do what we can going into the April 2025 elections, especially because of what happened during the last Wisconsin Supreme Court race, and the carnage the new liberal majority unleashed in a little over a year.

In 2023, liberal Milwaukee Judge Janet Protasiewicz dominated former Wisconsin Supreme Court justice Dan Kelly by 11 points, over 200,000 votes. Wisconsin is a purple state – Trump won the state by 29,000 votes, and Republican businessman Eric Hovde lost against Democrat US Senator Tammy Baldwin by 29,000 votes. So, how did Protasiewicz win so big?

First, Protasiewicz and her liberal allies spent more than \$30 million, twice as much as has ever been spent on a state Supreme Court race EVER in any state. She had five times more campaign ads than Dan Kelly. You may be wondering why rich liberals from California and New York care about what's going on in Wisconsin? Well, it's because even though the Wisconsin Supreme Court is officially nonpartisan, Protasiewicz broke judicial norms, promising liberal voters exactly how she would vote if she won. There is a legal rule called "stare decisis" that courts are supposed to follow- it means that judges should honor the precedent of previous decisions, rulings, and opinions from prior cases. Apparently Protasiewicz and her fellow liberal Wisconsin Supreme Court judges missed the day that was talked about in law school.

In a little over a year of holding office, she has tipped the balance of the court from center-right to hard liberal. First, Protasiewicz was the deciding vote to rule that the Wisconsin legislative maps that were just ruled constitutional are in fact illegal. The result is new maps that split communities and spread liberal Dane and Milwaukee Counties into rural Wisconsin seats, which flipped over a dozen races in favor of Democrats. Then she was the deciding vote to allow unmanned ballot drop boxes that only two years earlier were ruled illegal.

Protasiewicz is not up for re-election for eight years. But, next April there is an open race for Wisconsin Supreme Court. Liberal Ann Walsh Bradley (who has been on the court for 30 years) is not running. If a judicial conservative wins, the rule of law will be restored.

I think the April 2025 election will be different because candidate quality matters. Brad Schimel is the battle-tested champion for the moment. He has been vetted. He has statewide name recognition, serving as Attorney

General for four years. Brad Schimel joined the race more than one year ago. That head start allowed him to visit 65 of 72 counties already, be endorsed by 50 Sheriffs, and raise nearly \$2 million. Brad is endorsed by the Milwaukee Police Association, Milwaukee Professional Firefighters Association, the Waukesha County Police Chiefs Association, and Americans for Prosperity. "Tough on crime" isn't a campaign slogan for Brad Schimel – it's a calling. He's spent his life making Wisconsin safe, working alongside law enforcement, locking up criminals, and delivering justice for victims.

His opponent is a cookie cutter of the other liberal Wisconsin Judges. Susan Crawford is a blatant partisan focused on making all of Wisconsin look like Madison. As an attorney, she attempted to repeal Wisconsin's Voter ID Laws and Act 10. She pushed to free 3,000 prisoners early, supported no cash bail, and an end to real-time tracking of sex offenders.

Crawford is currently a Dane County Circuit Court Judge, where she has displayed a pattern of being soft on crime, defying prosecutors, and going easy on murderers.

If liberal Madison Judge Crawford wins the seat, the next opportunity to restore sanity to the Wisconsin Supreme Court will be three years away. During those three years, a liberal majority could get rid of every conservative reform passed by Governor Walker and the Republican legislature. For example:

- Elimination of Act 10.
- Elimination of Right to Work.
- Elimination of Voter ID

TO THE WISCONSIN ADMINISTRATIVE STATE

Through this Citizen's Guide we hope to spur an interest in greater civic engagement and involvement in the processes of government, namely in oversight of the administrative state in Wisconsin

History:

The administrative state has grown considerably since its "Progressive Era" inception. Here in Wisconsin progressive intellectuals conceived the "Wisconsin Idea," which laid the groundwork for a robust centralized bureaucracy in state government. A core philosophy behind the "Wisconsin Idea" was that our elected representatives should defer to the intelligentsia, like the professors of the University of Wisconsin.

This element of progressivism, that "experts" should be held above

elected officials, has moved beyond deference to academics, but has expanded to agency officials and bureaucrats. Over the years, the Wisconsin Legislature enacted new laws much like Congress – delegating ever-increasing powers. to the bureaucracy of agencies housed within the executive branch of government. These agencies, as we now know, eventually took on quasi-legislative and judicial functions antithetical to the separation of powers and our Founders' intent.

As the administrative state has become increasingly ascendant in all aspects of our lives, there is a greater need than ever before to fight back. As a result, it has become more important than ever for everyday citizens to get involved, demand transparency, and provide the necessary oversight to hold bureaucrats accountable to the very law which created them in the first instance. This guide is intended to help Wisconsin citizens do just that. Over the past decade, the Wisconsin Legislature began to re-assert its primary constitutional role as lawmaker in Wisconsin. Through various regulatory reform acts, the Legislature began the process of re-asserting its control over the administrative state in Wisconsin, especially through the elimination of "implied" agency power.

IMPORTANCE OF CITIZEN ENGAGEMENT

The Legislature stepping up is not enough – indeed the sheer size of the administrative state requires more oversight than legislators alone can provide. In order to truly pull back on the massive power that the administrative state wields over all of us, everyday citizens must actively participate in the regulatory process. This short guide is intended to provide an overview of the constitutional and statutory underpinnings of the administrative state, an overview of the rulemaking process, and an overview of how the Legislature and the public at large are empowered to hold agencies

accountable to the law, and what to do if an agency does not play by the rules

CITIZEN ENGAGEMENT OPPORTUNITY #1

Participate in Public Hearings: A great opportunity to be heard is by showing up to hearings, submitting comments, or both. Agencies must read and respond to your comments. There may be opportunities to testify at legislative reviews as well which helps hold government accountable. While the level of public interaction may differ for each rule depending

on a number of factors, generally these are the opportunities for a citizen to submit comments or testify on a proposed rule:

■ Scope Statement – Scope statements are not always subject to public comment or hearing requirements, but when they are, citizens have the opportunity to submit comments or testify.

■ Comment Period/Hearings on Draft **Rule** – Typically, agencies have public hearings around the state and also offer a virtual option for citizens to testify. Alternatively, agencies must have a period of public comment, where citizens can submit comments on a rule that agencies must respond to.

■ Standing Committee Hearing – Once a proposed rule reaches the Legislature, it is referred to the appropriate standing committee. Committee chairs have the discretion on whether or not to hold a hearing on a rule. If you would like to request a hearing, contact the chair of the committee.

■ Joint Committee for Review of Administrative Rules Hearing – JCRAR is the final step before a rule is fully implemented, and cochairs in both the Senate and Assembly must agree to hold a hearing on a proposed rule.

CITIZEN ENGAGEMENT OPPORTUNITY #2

Contact Public Officials: You do not have to be an expert to review administrative rules. Are you having trouble with an existing regulation? Is a proposed rule confusing? Reach out to your state representatives and ask them to take a closer look. Remember, they work for you. Alternatively, you can also contact WILL for assistance.

CITIZEN ENGAGEMENT OPPORTUNITY #3

Petition for a Rule Change: Any five individuals can petition for a rule change and the agency must respond within a reasonable amount of time. It can also aid in future policy decisions or possible future legal action.

CITIZEN ENGAGEMENT OPPORTUNITY #4

File a Lawsuit: If an agency fails to follow or engage in this process at all, a rule would not be lawfully adopted, and the Wisconsin courts

would be required to strike it down. A lawsuit is the only way to challenge the validity of a rule, and WILL can represent you in this type of agency action. @cmmm
